**Clause 3;** The Project Proponent shall be an active player in the oil industry engaged in physical bunkering or an oil major, bunker broker, major bunker supplier or such party with experience in the procurement and sale of bunker fuels and operation of a marine bunker terminal with barges, supplying varieties of bunker fuels to ships who should have handled a minimum of 750,000 MT of bunker fuels in a calendar year over a period of 02 years during the last 3 years
